4. Pricing and Payment

4.1 Rates and Pricing Structures

Each project is priced independently, and a standard hourly rate of £60 applies for additional work beyond the initially agreed scope.

Pay Monthly Graphic Design packages vary between £1,049 per month and £179 depending on the level of service. More information on these packages can be found on our website.

4.2 Upfront Payment

Full payment is required before Evolute Agency starts a project.

4.3 Methods of Payment

We accept payment via BACS, standing order, or direct debit.

5. Revisions and Changes

5.1 Revisions

The initial quote includes revisions, limited to one hour of additional work. Additional revisions beyond this scope may incur additional charges.

6. Turnground Time

6.1 Project Completion

The turnaround time for completed design projects depends on our current workload and the project's scope. Smaller projects can be expected to be returned within 2-3 working days, while larger projects may take between 7-10 working days.

7. Guarantees

7.1 Design Satisfaction Guarantee

We offer a 14-day design satisfaction guarantee. If you are not satisfied with the design, we will work with you to make necessary adjustments until you are satisfied.

7.2 Time-Saving Guarantee

We guarantee that our designs will save you hours spent on your marketing efforts.

7.3 Increased Enquiries Guarantee

We guarantee that you will see a 50% increase in your enquiries. If this guarantee is not met, we will continue working at a reduced rate or provide you with one month of service for free (applicable to monthly retainer clients).

8. Intellectual Property

Clients may cancel a project at any time, but no refunds will be issued.
